What is the 1689 London Baptist Confession?

The 1689 London Baptist Confession of Faith is a significant theological document that articulates the core beliefs of Particular Baptists. The confession meticulously outlines the "offices" of Christ as Prophet, Priest, and King. As Prophet, He reveals God's will; as Priest, He offers Himself as the ultimate atonement; and as King, He rules and governs His church. The atonement is understood as "limited" or "particular," meaning Christ died effectively for the elect, securing their salvation, rather than making salvation merely possible for all.

Salvation by Grace Through Faith

The doctrine of salvation by grace alone, through faith alone, in Christ alone is a cornerstone of the 1689 Confession. Chapters 10-18 delve into the process of salvation, including effectual calling, regeneration, adoption, justification, sanctification, and perseverance. Chapter 11, "Of Justification," defines justification as God's gracious act of declaring sinners righteous, not on the basis of their own merit, but through faith in Christ's atoning sacrifice, by which Christ's righteousness is imputed to them.

The confession clearly states that salvation is entirely God's work, initiated by His sovereign grace and applied by the Holy Spirit. Humans are unable to save themselves or even contribute to their salvation apart from God's prevenient grace. Faith is presented as the instrument through which a sinner receives and appropriates the benefits of Christ's work, but it is itself a gift from God.

The Holy Spirit's Role

The work of the Holy Spirit is vital to the confession's understanding of Christian life and salvation. Chapters 13, "Of Effectual Calling," and 14, "Of Saving Faith," highlight the Spirit's role in bringing about regeneration, imparting saving faith, and enabling believers to live a life pleasing to God. The Spirit indwells believers, illuminating their minds, convicting them of sin, assuring them of their adoption into God's family, and empowering them for sanctification and service.

The confession also addresses the gifts of the Holy Spirit, affirming their continued presence and operation in the church, though with a cautionary note against sensationalism or practices that are not clearly taught in Scripture. The Spirit's primary work is seen in sanctification – the progressive process of becoming more like Christ.

The Church and Its Ordinances

The confession dedicates significant attention to the nature and mission of the church, as well as its divinely appointed ordinances. Chapter 25, "Of the Church," defines the church as the invisible body of all the elect, and the visible church as composed of professing believers and their children. Chapter 28, "Of Baptism," and Chapter 29, "Of the Lord's Supper," outline the proper subjects and meaning of these sacraments. The confession

firmly rejects the Roman Catholic doctrine of transubstantiation and the practice of infant baptism, adhering to the belief that baptism is a visible sign for believers who have personally professed faith in Christ.

The Last Things: Resurrection and Judgment

The confession concludes by addressing eschatological doctrines, providing a framework for understanding the end times. Chapters 30, "Of the Ministry and Magistracy," 31, "Of the Resurrection of the Dead," and 32, "Of the Last Judgment and Final State of the Wicked and the Blessed," cover the return of Christ, the resurrection of believers and unbelievers, the final judgment, and the eternal destiny of the righteous in heaven and the wicked in hell. The confession affirms a literal, physical resurrection of both believers and unbelievers, followed by a final, universal judgment by Jesus Christ. It clearly articulates the eternal separation of the saved and the lost, emphasizing the glorious inheritance of believers and the just recompense of punishment for the unrepentant.
