

CONSPIRACY TO MURDER THE RWANDAN GENOCIDE

CONSPIRACY TO MURDER THE RWANDAN GENOCIDE IS A TERM THAT PROBES THE DEEP AND DISTURBING QUESTIONS SURROUNDING THE SYSTEMATIC EXTERMINATION OF TUTSIS AND MODERATE HUTUS IN RWANDA DURING 1994. THIS ARTICLE DELVES INTO THE INTRICATE WEB OF PLANNING, INCITEMENT, AND EXECUTION THAT CHARACTERIZED THIS HORRIFIC EVENT, EXAMINING THE VARIOUS ACTORS AND IDEOLOGIES THAT CONTRIBUTED TO THE GENOCIDE. WE WILL EXPLORE THE HISTORICAL CONTEXT, THE ROLE OF PROPAGANDA, THE INVOLVEMENT OF KEY INDIVIDUALS AND GROUPS, AND THE INTERNATIONAL COMMUNITY'S RESPONSE, OR LACK THEREOF, TO THIS DEVASTATING PERIOD. UNDERSTANDING THE MECHANICS OF THIS CONSPIRACY IS CRUCIAL FOR REMEMBRANCE, JUSTICE, AND PREVENTING FUTURE ATROCITIES.

UNDERSTANDING THE PRECURSORS TO GENOCIDE

THE RWANDAN GENOCIDE DID NOT ERUPT SPONTANEOUSLY; IT WAS THE CULMINATION OF DECADES OF ESCALATING ETHNIC TENSIONS, POLITICAL MANIPULATION, AND SOCIO-ECONOMIC DISPARITIES. THE SEEDS OF THIS DEVASTATING CONFLICT WERE SOWN LONG BEFORE THE ACTUAL KILLINGS BEGAN IN 1994. COLONIAL LEGACIES, PARTICULARLY THE BELGIAN ADMINISTRATION'S POLICIES, PLAYED A SIGNIFICANT ROLE IN EXACERBATING EXISTING ETHNIC DIVISIONS BETWEEN HUTU AND TUTSI POPULATIONS. THESE POLICIES OFTEN FAVORED ONE GROUP OVER THE OTHER, CREATING A SYSTEM OF PRIVILEGE AND RESENTMENT THAT FESTERED OVER TIME.

COLONIAL LEGACIES AND ETHNIC STRATIFICATION

DURING THE COLONIAL ERA, BELGIAN RULERS SOLIDIFIED AND RACIALIZED THE HUTU AND TUTSI IDENTITIES. THEY INTRODUCED IDENTITY CARDS THAT EXPLICITLY MARKED INDIVIDUALS AS EITHER HUTU OR TUTSI, SOLIDIFYING THESE CATEGORIES AND, IN MANY WAYS, CREATING A RIGID SOCIAL HIERARCHY. THE BELGIANS OFTEN PERCEIVED THE TUTSIS AS A MORE ARISTOCRATIC AND FAVORED GROUP, WHILE THE HUTUS WERE VIEWED AS THE MAJORITY PEASANT POPULATION. THIS MANUFACTURED DISTINCTION, COUPLED WITH PREFERENTIAL TREATMENT FOR TUTSIS IN EDUCATION AND ADMINISTRATION, FOSTERED DEEP-SEATED ANIMOSITY AND A SENSE OF HISTORICAL INJUSTICE AMONG THE HUTU POPULATION.

POST-INDEPENDENCE POLITICAL INSTABILITY

FOLLOWING RWANDA'S INDEPENDENCE IN 1962, THE POLITICAL LANDSCAPE WAS CHARACTERIZED BY INSTABILITY AND CYCLES OF VIOLENCE. THE HUTU MAJORITY GAINED POLITICAL POWER, AND THIS OFTEN TRANSLATED INTO DISCRIMINATORY POLICIES AND PERIODIC MASSACRES AGAINST THE TUTSI MINORITY. THESE EVENTS, WHILE NOT ON THE GENOCIDAL SCALE OF 1994, CREATED A CLIMATE OF FEAR AND VULNERABILITY FOR TUTSIS AND REINFORCED THE NARRATIVE OF ETHNIC CONFLICT. THE HUTU REVOLUTION OF 1959, WHICH SAW A SIGNIFICANT NUMBER OF TUTSIS FLEE THE COUNTRY, FURTHER POLARIZED THE NATION

AND ESTABLISHED A PRECEDENT FOR ETHNIC CLEANSING.

THE RWANDAN PATRIOTIC FRONT (RPF) INVASION AND ESCALATING TENSIONS

THE INVASION BY THE RWANDAN PATRIOTIC FRONT (RPF) IN 1990, COMPOSED LARGELY OF TUTSI REFUGEES WHO HAD BEEN EXILED IN PREVIOUS DECADES, MARKED A CRITICAL TURNING POINT. THIS ARMED STRUGGLE AGAINST THE HUTU-DOMINATED GOVERNMENT INTENSIFIED ETHNIC TENSIONS AND PROVIDED A PRETEXT FOR HARDLINE ELEMENTS WITHIN THE GOVERNMENT AND MILITARY TO ESCALATE THEIR PLANNING FOR MORE EXTREME MEASURES. THE RPF'S MILITARY ACTIONS WERE FRAMED BY THE GOVERNMENT AS AN EXISTENTIAL THREAT TO THE HUTU PEOPLE, A NARRATIVE THAT WAS METICULOUSLY CRAFTED TO JUSTIFY FUTURE ACTIONS.

THE IDEOLOGICAL UNDERPINNINGS OF THE CONSPIRACY

AT THE HEART OF THE CONSPIRACY TO MURDER THE RWANDAN GENOCIDE LAY A VIRULENT IDEOLOGY OF ETHNIC HATRED AND DEHUMANIZATION, PRIMARILY DIRECTED AGAINST THE TUTSI POPULATION. THIS IDEOLOGY WAS NOT JUST A COLLECTION OF ABSTRACT BELIEFS; IT WAS A CAREFULLY CONSTRUCTED WORLDVIEW THAT PORTRAYED TUTSIS AS AN ALIEN ENEMY, A THREAT TO THE VERY EXISTENCE OF THE HUTU NATION. THE ARCHITECTS OF THE GENOCIDE SOUGHT TO CREATE A SOCIETY FREE FROM TUTSI INFLUENCE, BELIEVING THAT THEIR EXTERMINATION WAS A NECESSARY STEP FOR NATIONAL PURITY AND SECURITY.

HUTU POWER IDEOLOGY

THE DRIVING FORCE BEHIND THE GENOCIDAL CONSPIRACY WAS THE EXTREMIST HUTU POWER IDEOLOGY. THIS IDEOLOGY PROMOTED THE IDEA OF HUTU SUPREMACY AND POSITED THAT TUTSIS WERE AN ILLEGITIMATE MINORITY WHO HAD HISTORICALLY OPPRESSED THE HUTU MAJORITY. IT WAS CHARACTERIZED BY EXTREME NATIONALISM, XENOPHOBIA, AND A DEEP-SEATED RESENTMENT TOWARDS ANY PERCEIVED TUTSI INFLUENCE. HUTU POWER ADVOCATES BELIEVED THAT THE RWANDAN STATE BELONGED EXCLUSIVELY TO THE HUTUS AND THAT TUTSIS WERE AN INVASIVE FORCE THAT NEEDED TO BE ERADICATED.

DEHUMANIZATION OF THE TUTSI POPULATION

A CRUCIAL ELEMENT OF THE GENOCIDAL CONSPIRACY WAS THE SYSTEMATIC DEHUMANIZATION OF THE TUTSI POPULATION. THROUGH PROPAGANDA, TUTSIS WERE DEPICTED AS COCKROACHES, SNAKES, OR ENEMIES OF THE STATE. THIS DEHUMANIZING LANGUAGE WAS ESSENTIAL FOR OVERCOMING THE NATURAL HUMAN AVERSION TO KILLING AND FOR PORTRAYING THE EXTERMINATION AS A FORM OF PEST CONTROL OR SELF-DEFENSE. BY STRIPPING TUTSIS OF THEIR HUMANITY, PERPETRATORS COULD JUSTIFY AND CARRY OUT MASS ATROCITIES WITH A CHILLING DETACHMENT.

THE "RACHID" PROPAGANDA CAMPAIGN

THE TERM "RACHID" BECAME SYNONYMOUS WITH A CLANDESTINE RADIO STATION THAT PLAYED A PIVOTAL ROLE IN SPREADING HATEFUL PROPAGANDA AND DIRECTING THE GENOCIDE. THIS STATION, ALONGSIDE OTHERS, RELENTLESSLY BROADCAST MESSAGES THAT INCITED VIOLENCE, IDENTIFIED TARGETS, AND EVEN PROVIDED INSTRUCTIONS ON HOW TO CARRY OUT KILLINGS. THE DELIBERATE AND SUSTAINED NATURE OF THIS PROPAGANDA CAMPAIGN DEMONSTRATES A CLEAR INTENT TO MANIPULATE THE POPULATION AND MOBILIZE THEM FOR MASS MURDER.

KEY ARCHITECTS AND ENABLERS OF THE GENOCIDE

THE RWANDAN GENOCIDE WAS NOT A SPONTANEOUS UPRISING OF THE MASSES; IT WAS A METICULOUSLY PLANNED AND ORCHESTRATED EVENT EXECUTED BY A NETWORK OF INDIVIDUALS AND GROUPS WITHIN RWANDA'S POLITICAL, MILITARY, AND

CIVILIAN STRUCTURES. UNDERSTANDING THE ROLES OF THESE KEY ARCHITECTS AND ENABLERS IS VITAL TO COMPREHENDING THE NATURE OF THE CONSPIRACY. THESE INDIVIDUALS, DRIVEN BY EXTREMIST IDEOLOGY AND A LUST FOR POWER, ACTIVELY PLANNED, FUNDED, AND DIRECTED THE EXTERMINATION CAMPAIGN.

POLITICAL LEADERSHIP AND THE MRND PARTY

THE RULING PARTY AT THE TIME, THE MOUVEMENT RÉPUBLICAIN NATIONAL POUR LE DÉVELOPPEMENT ET LA DÉMOCRATIE (MRND), AND ITS HARDLINE FACTION, WERE CENTRAL TO THE GENOCIDAL CONSPIRACY. PRESIDENT JUVÉNAL HABYARIMANA, THOUGH HIS DIRECT INVOLVEMENT IS DEBATED, PRESIDED OVER A REGIME THAT FACILITATED THE RISE OF HUTU POWER EXTREMISM. KEY FIGURES WITHIN HIS GOVERNMENT AND THE MRND WERE INSTRUMENTAL IN SETTING THE STAGE FOR THE GENOCIDE, PROMOTING DIVISIVE POLICIES, AND CREATING THE NECESSARY POLITICAL AND ADMINISTRATIVE FRAMEWORK FOR ITS EXECUTION.

MILITARY AND PARAMILITARY INVOLVEMENT

THE RWANDAN ARMED FORCES (FAR) AND VARIOUS PARAMILITARY GROUPS, SUCH AS THE INTERAHAMWE AND THE IMPUZAMUGAMBI, WERE THE PRIMARY INSTRUMENTS OF THE GENOCIDE. THESE FORCES WERE TRAINED, ARMED, AND OFTEN DIRECTLY COMMANDED BY INDIVIDUALS WHO WERE PART OF THE GENOCIDAL CONSPIRACY. THE INTERAHAMWE, IN PARTICULAR, EVOLVED FROM A YOUTH WING OF THE MRND INTO A BRUTAL MILITIA THAT PLAYED A LEADING ROLE IN THE MASS KILLINGS. THEIR WIDESPREAD PRESENCE AND COORDINATED ATTACKS ACROSS THE COUNTRY UNDERScore THE ORGANIZED NATURE OF THE CONSPIRACY.

CIVILIAN COLLABORATORS AND LOCAL AUTHORITIES

BEYOND THE POLITICAL AND MILITARY ELITES, A VAST NETWORK OF CIVILIAN COLLABORATORS AND LOCAL AUTHORITIES ACTIVELY PARTICIPATED IN AND ENABLED THE GENOCIDE. MAYORS, LOCAL ADMINISTRATORS, AND EVEN ORDINARY CITIZENS WERE OFTEN COERCED OR MOTIVATED TO PARTICIPATE IN THE KILLINGS, IDENTIFY TUTSI NEIGHBORS, OR TURN A BLIND EYE TO THE ATROCITIES. THIS WIDESPREAD COMPLICITY HIGHLIGHTS HOW THE CONSPIRACY INFILTRATED ALL LEVELS OF RWANDAN SOCIETY, TRANSFORMING COMMUNITIES INTO ARENAS OF TERROR.

THE ROLE OF PROPAGANDA AND INCITEMENT

PROPAGANDA SERVED AS A CORNERSTONE OF THE CONSPIRACY TO MURDER THE RWANDAN GENOCIDE, EFFECTIVELY PREPARING THE GROUND FOR MASS VIOLENCE AND MAINTAINING MOMENTUM DURING THE KILLINGS. THROUGH RADIO, PRINT MEDIA, AND PUBLIC RALLIES, EXTREMIST ELEMENTS SYSTEMATICALLY DISSEMINATED HATEFUL MESSAGES DESIGNED TO DEHUMANIZE THE TUTSI POPULATION AND INCITE HUTUS TO PARTICIPATE IN THEIR EXTERMINATION. THIS DELIBERATE MANIPULATION OF PUBLIC OPINION WAS NOT INCIDENTAL; IT WAS A CRITICAL COMPONENT OF THE GENOCIDAL STRATEGY.

RADIO TÉLÉVISION LIBRE DES MILLE COLLINES (RTLM)

RADIO TÉLÉVISION LIBRE DES MILLE COLLINES (RTLM) WAS ARGUABLY THE MOST POTENT TOOL OF GENOCIDAL PROPAGANDA. THIS PRIVATELY OWNED RADIO STATION BECAME INFAMOUS FOR ITS VIRULENT HATE SPEECH, BROADCASTING MESSAGES THAT CALLED FOR THE EXTERMINATION OF TUTSIS AND EVEN BROADCAST THE NAMES AND LOCATIONS OF INDIVIDUALS TO BE TARGETED. RTLM PLAYED A DIRECT ROLE IN COORDINATING THE KILLINGS AND FOSTERING AN ATMOSPHERE OF FEAR AND OBEDIENCE AMONG THE PERPETRATORS.

PRINT MEDIA AND PAMPHLETS

BEYOND RADIO, PRINT MEDIA AND VARIOUS PAMPHLETS ALSO DISSEMINATED GENOCIDAL PROPAGANDA. NEWSPAPERS AND PUBLICATIONS ASSOCIATED WITH HUTU POWER IDEOLOGY REGULARLY PUBLISHED ARTICLES THAT DEMONIZED TUTSIS, PERPETUATED CONSPIRACY THEORIES, AND GLORIFIED VIOLENCE. THESE MATERIALS SERVED TO REINFORCE THE MESSAGES BROADCAST ON RADIO AND TO PROVIDE A CONSTANT STREAM OF HATEFUL RHETORIC THAT PERMEATED RWANDAN SOCIETY.

INCITEMENT TO VIOLENCE AND THE "WORK" OF EXTERMINATION

THE PROPAGANDA CONSISTENTLY FRAMED THE GENOCIDE AS A "WORK" OR A "REVOLUTION" TO CLEANSE RWANDA OF THE "TUTSI ENEMY." CALLS TO ACTION WERE DIRECT AND UNAMBIGUOUS, URGING HUTUS TO RISE UP AND ELIMINATE TUTSIS. THE LANGUAGE USED WAS DESIGNED TO CREATE A SENSE OF URGENCY AND TO NORMALIZE THE ACT OF KILLING. THIS PERVERSIVE INCITEMENT PLAYED A CRUCIAL ROLE IN MOBILIZING A LARGE NUMBER OF PERPETRATORS AND ENSURING THE WIDESPREAD NATURE OF THE ATROCITIES.

THE MECHANICS OF THE EXECUTION: FROM PLANNING TO SLAUGHTER

THE SUCCESSFUL EXECUTION OF THE RWANDAN GENOCIDE INVOLVED A COMPLEX SET OF LOGISTICAL AND OPERATIONAL PLANNING. THE CONSPIRACY MOVED BEYOND MERE IDEOLOGICAL PRONOUNCEMENTS TO CONCRETE ACTIONS THAT FACILITATED THE SYSTEMATIC EXTERMINATION OF AN ESTIMATED 800,000 TO 1 MILLION PEOPLE IN APPROXIMATELY 100 DAYS. THIS INVOLVED THE METICULOUS PREPARATION OF LISTS, THE DISTRIBUTION OF WEAPONS, AND THE COORDINATION OF ATTACKS ACROSS THE COUNTRY.

PREPARATION OF TARGET LISTS

EVIDENCE SUGGESTS THAT PRE-EXISTING LISTS OF TUTSIS AND MODERATE HUTUS WERE COMPILED BY THE ARCHITECTS OF THE GENOCIDE. THESE LISTS, OFTEN BASED ON IDENTITY CARDS AND KNOWLEDGE OF LOCAL COMMUNITIES, WERE USED TO IDENTIFY AND TARGET VICTIMS EFFICIENTLY. THE EXISTENCE OF THESE LISTS POINTS TO A PRE-MEDITATED PLAN RATHER THAN A SPONTANEOUS OUTBREAK OF VIOLENCE.

DISTRIBUTION OF WEAPONS AND TRAINING

THE WIDESPREAD DISTRIBUTION OF WEAPONS, INCLUDING MACHETES, CLUBS, AND FIREARMS, WAS A CRITICAL ASPECT OF THE GENOCIDAL MACHINERY. PARAMILITARY GROUPS AND THE GENERAL POPULATION WERE ARMED, OFTEN WITH WEAPONS PROCURED THROUGH STATE CHANNELS OR DISTRIBUTED BY THE ORGANIZERS OF THE GENOCIDE. TRAINING SESSIONS WERE ALSO CONDUCTED TO INSTRUCT MILITIAS AND ORDINARY CITIZENS ON HOW TO CARRY OUT KILLINGS.

COORDINATED ATTACKS AND CHECKPOINTS

THE GENOCIDE WAS CHARACTERIZED BY COORDINATED ATTACKS ON TUTSI COMMUNITIES, CHURCHES, SCHOOLS, AND OTHER PLACES WHERE PEOPLE SOUGHT REFUGE. ROADBLOCKS AND CHECKPOINTS WERE ESTABLISHED TO INTERCEPT FLEEING TUTSIS AND TO EXTORT BRIBES OR CARRY OUT KILLINGS. THE SYSTEMATIC NATURE OF THESE ATTACKS ACROSS THE COUNTRY, OFTEN OCCURRING SIMULTANEOUSLY, POINTS TO A HIGH DEGREE OF PLANNING AND CENTRALIZED DIRECTION.

THE ROLE OF THE HUTU TEN COMMANDMENTS

THE "HUTU TEN COMMANDMENTS," A DOCUMENT THAT OUTLINED A RACIST AND DISCRIMINATORY IDEOLOGY, SERVED AS A DE FACTO MANIFESTO FOR THE GENOCIDE. IT CALLED FOR THE SEGREGATION OF HUTUS AND TUTSIS, THE EXCLUSION OF TUTSIS FROM ALL POSITIONS OF POWER, AND THE ELIMINATION OF "ACCOMPLICES" OF THE TUTSIS. THIS DOCUMENT, WIDELY

DISSEMINATED AND PROMOTED, PROVIDED A FRAMEWORK AND JUSTIFICATION FOR THE SYSTEMATIC EXTERMINATION.

INTERNATIONAL NEGLECT AND THE FAILURE TO INTERVENE

A DEEPLY TROUBLING ASPECT OF THE RWANDAN GENOCIDE CONSPIRACY IS THE INTERNATIONAL COMMUNITY'S FAILURE TO INTERVENE EFFECTIVELY TO PREVENT OR STOP THE ATROCITIES. DESPITE MOUNTING EVIDENCE AND CLEAR WARNINGS, MAJOR WORLD POWERS AND INTERNATIONAL ORGANIZATIONS LARGELY STOOD BY AS THE EXTERMINATION UNFOLDED, RAISING PROFOUND QUESTIONS ABOUT GLOBAL RESPONSIBILITY AND THE EFFECTIVENESS OF INTERNATIONAL MECHANISMS FOR PREVENTING GENOCIDE.

UNDERESTIMATION OF THE THREAT

MANY INTERNATIONAL ACTORS INITIALLY UNDERESTIMATED THE SCALE AND INTENT OF THE VIOLENCE. THE CONFLICT WAS OFTEN FRAMED AS A CIVIL WAR OR AN ETHNIC DISPUTE, RATHER THAN A SYSTEMATIC ACT OF GENOCIDE. THIS UNDERESTIMATION, COUPLED WITH A RELUCTANCE TO GET INVOLVED IN ANOTHER AFRICAN CONFLICT FOLLOWING THE SOMALIA DEBACLE, CONTRIBUTED TO A PASSIVE RESPONSE.

THE WITHDRAWAL OF UN PEACEKEEPERS

THE UNITED NATIONS ASSISTANCE MISSION FOR RWANDA (UNAMIR) WAS PRESENT IN THE COUNTRY AT THE OUTBREAK OF THE GENOCIDE. HOWEVER, WHEN THE KILLINGS BEGAN, THE SECURITY COUNCIL VOTED TO SIGNIFICANTLY REDUCE THE SIZE OF UNAMIR, LEAVING THE REMAINING PEACEKEEPERS ILL-EQUIPPED AND UNDER-MANDATED TO INTERVENE. THIS DECISION EFFECTIVELY ABANDONED THE TUTSI POPULATION TO THE PERPETRATORS.

LACK OF POLITICAL WILL AND NATIONAL INTERESTS

A LACK OF POLITICAL WILL AMONG POWERFUL NATIONS, DRIVEN BY PERCEIVED NATIONAL INTERESTS AND A RELUCTANCE TO COMMIT RESOURCES AND TROOPS, WAS A MAJOR IMPEDIMENT TO INTERVENTION. THE INTERNATIONAL COMMUNITY'S RESPONSE WAS CHARACTERIZED BY INDECISION, BUREAUCRATIC INERTIA, AND A FAILURE TO RECOGNIZE THE URGENCY OF THE SITUATION AS A GENOCIDE, WHICH WOULD HAVE TRIGGERED LEGAL OBLIGATIONS TO ACT.

POST-GENOCIDE ACCOUNTABILITY AND THE SEARCH FOR JUSTICE

IN THE AFTERMATH OF THE RWANDAN GENOCIDE, SIGNIFICANT EFFORTS HAVE BEEN MADE TO BRING PERPETRATORS TO JUSTICE AND TO ESTABLISH ACCOUNTABILITY FOR THE CONSPIRACY TO MURDER. THESE EFFORTS HAVE INVOLVED INTERNATIONAL TRIBUNALS, NATIONAL JUDICIAL PROCESSES, AND COMMUNITY-BASED RECONCILIATION MECHANISMS. THE PURSUIT OF JUSTICE REMAINS AN ONGOING AND COMPLEX ENDEAVOR, AIMING TO PROVIDE REDRESS FOR VICTIMS AND TO DETER FUTURE ATROCITIES.

THE INTERNATIONAL CRIMINAL TRIBUNAL FOR RWANDA (ICTR)

THE INTERNATIONAL CRIMINAL TRIBUNAL FOR RWANDA (ICTR), ESTABLISHED BY THE UNITED NATIONS SECURITY COUNCIL, PLAYED A CRUCIAL ROLE IN PROSECUTING INDIVIDUALS RESPONSIBLE FOR GENOCIDE AND OTHER SERIOUS VIOLATIONS OF INTERNATIONAL HUMANITARIAN LAW. THE ICTR SUCCESSFULLY CONVICTED NUMEROUS HIGH-RANKING OFFICIALS, MILITARY COMMANDERS, AND MILITIA LEADERS, CONTRIBUTING TO THE UNDERSTANDING OF THE CONSPIRACY AND ITS PERPETRATORS.

NATIONAL PROSECUTIONS AND GACACA COURTS

RWANDA ITSELF HAS UNDERTAKEN EXTENSIVE EFFORTS TO PROSECUTE GENOCIDE PERPETRATORS THROUGH ITS NATIONAL JUDICIAL SYSTEM. ADDITIONALLY, THE COUNTRY REVIVED THE TRADITIONAL GACACA COURTS, A COMMUNITY-BASED JUSTICE SYSTEM DESIGNED TO HANDLE THE VAST NUMBER OF CASES AND TO PROMOTE RECONCILIATION. WHILE CONTROVERSIAL, GACACA COURTS HAVE PLAYED A SIGNIFICANT ROLE IN PROCESSING CASES AND PROVIDING SOME MEASURE OF JUSTICE TO SURVIVORS.

THE ONGOING STRUGGLE FOR REMEMBRANCE AND PREVENTION

THE LEGACY OF THE RWANDAN GENOCIDE CONSPIRACY CONTINUES TO SHAPE RWANDA AND THE INTERNATIONAL COMMUNITY'S UNDERSTANDING OF MASS ATROCITIES.
