CONNECTICUT BAR EXAM: AN OVERVIEW FOR 2022 ASPIRANTS

THE CONNECTICUT BAR EXAM IS A RIGOROUS ASSESSMENT DESIGNED TO EVALUATE A CANDIDATE'S KNOWLEDGE OF FUNDAMENTAL LEGAL PRINCIPLES AND THEIR ABILITY TO APPLY THAT KNOWLEDGE IN A PRACTICAL SETTING. ADMINISTERED BY THE CONNECTICUT BOARD OF BAR EXAMINERS, THE EXAM IS A GATEWAY TO PRACTICING LAW WITHIN THE STATE. FACTORS INFLUENCING BAR EXAM PERFORMANCE AND 2022 RESULTS

WHAT WAS THE OVERALL PASS RATE FOR THE CONNECTICUT BAR EXAM IN 2022?

THE OVERALL PASS RATE FOR THE CONNECTICUT BAR EXAM IN JULY 2022 WAS APPROXIMATELY 68.7%, WITH 720 OUT OF 1050 CANDIDATES PASSING.

WERE THERE ANY SIGNIFICANT CHANGES TO THE CONNECTICUT BAR EXAM IN 2022?

FOR THE 2022 EXAMS (FEBRUARY AND JULY), CONNECTICUT CONTINUED TO ADMINISTER THE UNIFORM BAR EXAM (UBE), WHICH INCLUDES THE MULTISTATE BAR EXAMINATION (MBE), MULTISTATE ESSAY EXAMINATION (MEE), AND MULTISTATE PERFORMANCE TEST (MPT).

HOW DOES THE CONNECTICUT BAR EXAM PASS RATE IN 2022 COMPARE TO PREVIOUS YEARS?

THE JULY 2022 PASS RATE OF 68.7% WAS SLIGHTLY LOWER THAN THE JULY 2021 PASS RATE OF APPROXIMATELY 72.5%, CONTINUING A TREND OF FLUCTUATING PASS RATES SEEN NATIONALLY.

WHAT ARE THE REQUIREMENTS TO PASS THE CONNECTICUT BAR EXAM?

CANDIDATES MUST ACHIEVE A MINIMUM SCALED SCORE OF 266 ON THE UBE. CONNECTICUT ALSO REQUIRES A MINIMUM SCORE OF 80 ON THE MPT AND 90 ON THE MEE.

CAN I REVIEW MY CONNECTICUT BAR EXAM RESULTS IF I DIDN'T PASS?

YES, CANDIDATES WHO DID NOT PASS THE CONNECTICUT BAR EXAM ARE TYPICALLY OFFERED THE OPPORTUNITY TO REVIEW THEIR EXAM PAPERS. INFORMATION ON HOW TO REQUEST A REVIEW IS USUALLY PROVIDED WITH THE RESULTS OR ON THE CONNECTICUT BAR EXAMINING COMMITTEE'S WEBSITE.
