Financial and Employment Questions

Financial stability and the ability to support the fiancé(e) financially is a key factor in the K1 visa process. The consular officer will assess whether the U.S. citizen sponsor meets the income requirements and whether the applicant is financially prepared.

Employment and Income Verification

Questions in this section aim to confirm employment status, income, and financial support plans.

- What is your current employment status?
- Where do you work and what is your job title?

- How long have you been employed there?
- What is your annual income?
- Are you able to financially support your fiancé(e)?
- Does your fiancé(e) have any employment or income?
- Do you have any assets or savings?
- Have you filed the Affidavit of Support (Form I-134)?

Financial Responsibility and Living Arrangements

The officer may ask about how the couple plans to manage finances and living arrangements after marriage.

- Where do you plan to live after marriage?
- Who will pay for the wedding expenses?

- Will your fiancé(e) work in the United States?

Future Plans and Marriage Intentions Questions

These questions focus on the couple's intentions after entry to the United States, ensuring the K1 visa is used for its intended purpose: marriage.

Marriage Plans and Timeline

The consular officer will want to confirm the applicant's commitment to marry within the 90-day period and other related plans.
