GROWING UP, BUNDY EXHIBITED BEHAVIORS THAT WERE OFTEN QUIET AND RESERVED, BUT HE ALSO DISPLAYED SIGNS OF SOCIAL AWKWARDNESS AND STRUGGLES WITH IDENTITY.

EDUCATION AND EARLY BEHAVIOR

BUNDY ATTENDED VARIOUS SCHOOLS AND WAS CONSIDERED AN AVERAGE STUDENT. HE SHOWED INTEREST IN PSYCHOLOGY AND HAD A FASCINATION WITH LAW AND CRIMINAL BEHAVIOR. DESPITE HIS OUTWARD NORMALCY, BUNDY HAD DIFFICULTIES FORMING GENUINE RELATIONSHIPS AND WAS KNOWN TO BE MANIPULATIVE FROM A YOUNG AGE. HIS EARLY BEHAVIORAL PATTERNS HINTED AT THE DARKER ASPECTS OF HIS PERSONALITY THAT WOULD EMERGE LATER IN LIFE.

CRIMINAL ACTIVITIES AND MODUS OPERANDI

VICTIM PROFILE AND PATTERNS

THE HISTORY OF TED BUNDY'S CRIMINAL ACTIVITIES REVEALS A DISTURBING PATTERN IN HIS SELECTION OF VICTIMS AND METHODS. BUNDY PRIMARILY TARGETED YOUNG WOMEN, OFTEN RESEMBLING A SPECIFIC PHYSICAL TYPE—TYPICALLY WITH LONG HAIR PARTED IN THE MIDDLE. HE USED CHARM AND DECEIT TO LURE VICTIMS, FREQUENTLY FEIGNING INJURY OR DISABILITY TO GAIN THEIR TRUST. HIS CRIMES SPANNED MULTIPLE STATES, INCLUDING WASHINGTON, UTAH

WHO WAS TED BUNDY?

TED BUNDY WAS AN AMERICAN SERIAL KILLER, KIDNAPPER, AND RAPIST WHO COMMITTED NUMEROUS CRIMES DURING THE 1970s.

WHEN DID TED BUNDY'S CRIMINAL ACTIVITIES BEGIN?

TED BUNDY'S KNOWN CRIMINAL ACTIVITIES BEGAN IN THE EARLY 1970s, WITH HIS FIRST CONFIRMED MURDER OCCURRING IN 1974.

TED BUNDY WAS FIRST ARRESTED IN 1975 FOR KIDNAPPING, ESCAPED CUSTODY TWICE, AND WAS FINALLY CAPTURED IN 1978 AFTER A TRAFFIC STOP IN FLORIDA.

TED BUNDY'S TRIAL WAS HIGHLY PUBLICIZED BECAUSE HE ACTED AS HIS OWN ATTORNEY AND BECAUSE OF THE BRUTAL NATURE OF HIS CRIMES.

HOW MANY VICTIMS DID TED BUNDY HAVE?

TED BUNDY CONFESSED TO KILLING 30 YOUNG WOMEN, BUT THE ACTUAL NUMBER OF VICTIMS IS BELIEVED TO BE HIGHER.

WHAT WAS THE OUTCOME OF TED BUNDY'S TRIAL?

TED BUNDY WAS CONVICTED AND SENTENCED TO DEATH FOR HIS CRIMES. HE WAS EXECUTED IN THE ELECTRIC CHAIR IN 1989.

WHAT IMPACT DID TED BUNDY'S CASE HAVE ON CRIMINAL PROFILING?
