ANSWER: PULL OVER TO THE RIGHT SIDE OF THE ROAD AND STOP UNTIL THE VEHICLE PASSES.

4. **QUESTION:** WHAT DOES A YELLOW DIAMOND-SHAPED SIGN INDICATE?

ANSWER: A WARNING OR CAUTION ABOUT ROAD CONDITIONS AHEAD.

TEST DAY PREPARATION AND REQUIREMENTS
