OVERVIEW OF THE NASSAU COUNTY POLICE EXAM 2018

PURPOSE OF THE EXAM

ELIGIBILITY AND APPLICATION PROCESS

INTERESTED CANDIDATES HAD TO CAREFULLY REVIEW OFFICIAL ANNOUNCEMENTS AND INSTRUCTIONS PROVIDED BY THE NASSAU COUNTY CIVIL SERVICE DEPARTMENT. LATE OR INCOMPLETE APPLICATIONS WERE TYPICALLY DISQUALIFIED, EMPHASIZING THE IMPORTANCE OF ATTENTION TO DETAIL DURING THE SUBMISSION PROCESS.

EXAM FORMAT AND CONTENT

- **SITUATIONAL JUDGMENT:** SCENARIOS REQUIRING CANDIDATES TO CHOOSE THE MOST APPROPRIATE RESPONSE BASED ON POLICE PROTOCOLS.

SCORING AND PASSING CRITERIA

EACH SECTION OF THE EXAM CONTRIBUTED TO A COMPOSITE SCORE USED TO RANK CANDIDATES. WHILE EXACT PASSING SCORES VARIED, ACHIEVING A HIGH SCORE WAS ESSENTIAL TO GAIN ELIGIBILITY FOR FURTHER HIRING STEPS. SCORES WERE TYPICALLY VALID FOR A LIMITED TIME, DURING WHICH CANDIDATES COULD BE CONSIDERED FOR APPOINTMENT.

PREPARATION STRATEGIES AND RESOURCES
