ORIGINS AND PURPOSE OF THE BILDERBERG GROUP

THE INITIAL INVITATION LIST INCLUDED INFLUENTIAL FIGURES SUCH AS PRINCE BERNHARD OF THE NETHERLANDS AND FUTURE US SECRETARY OF STATE HENRY KISSINGER. THE GROUP'S UNOFFICIAL MISSION WAS TO CREATE A TRANSATLANTIC DIALOGUE THAT COULD PREVENT MISUNDERSTANDINGS AND PROMOTE PEACE DURING A TIME MARKED BY GEOPOLITICAL TENSION. MEETINGS WERE DELIBERATELY KEPT PRIVATE TO ENCOURAGE FRANK EXCHANGES. THIS FOUNDATION LAID THE GROUNDWORK FOR THE BILDERBERG GROUP'S ENDURING REPUTATION AS AN EXCLUSIVE AND SECRETE FORUM.

EVOLUTION OF PURPOSE OVER TIME

WHILE THE ORIGINAL FOCUS WAS ON COLD WAR DIPLOMACY, THE BILDERBERG GROUP'S AGENDA EXPANDED TO COVER A WIDE ARRAY OF GLOBAL ISSUES, INCLUDING ECONOMIC POLICY, TECHNOLOGICAL INNOVATION, ENVIRONMENTAL CHALLENGES, AND SECURITY.
